

#### FY 2019 Year in Review:

**Bottom Line Up Front:** We received the FY 2019 reports through 30 September. We ended FY 2019 in the black by **\$12,374.** Income totalled \$62,434 and Expenses totalled \$50,069.

**Dues Status:** We received \$22,308 in Dues, which puts us ahead by \$708 for the year. We have also received \$971 in Contributions, which puts us ahead by \$479.

**Bank balances:** As of 9/30/2019, the bank balance in Service First is \$91,717.53. SWR needed to maintain \$84,000 in the bank for reserves (18 months expenses as projected in the FY 19 Budget).



## **New Business:**

**FY 2020 Budget:** With the changes approved by email, the FY 2020 budget was approved through Sertifi:

Total Expected Income: \$64,350Total Expected Expenses: \$64,350

• Minimum Reserves: \$96,525

**Bottom Line Up Front:** As of 31 October, we are in the black by \$2,751.73.

**Dues Status:** As of 31 Oct, we received \$2,245 in Dues, which puts us ahead by \$445. We have also received \$12 in Contributions, which puts us behind by \$29.

**Bank balances:** As of 10/31/2019, the bank balance in Service First is \$95,650.38. SWR needs to maintain \$96,525 in the bank for reserves (18 months expenses as projected in the FY 20 Budget).

### **Vanguard Funds:**

SWR received \$7,400 in Vanguard funds for FY 19 and added it to the budget. We will carryover \$2,271.34 to FY 2020. This is how the funds were used:
